



Prohibited Articles

■ **Prohibited Articles** ■ The following articles are prohibited from entry by law to Japan

1. Heroin, cocaine, MDMA, opium, cannabis, stimulants, psychotropic substances, and other narcotic drugs (excluding those designated by Ministry of Health, Labour and Welfare Ordinance);
2. Firearms (pistols, etc.), ammunition (bullets) thereof, and pistol parts;
3. Explosives (dynamite, gunpowder, etc.) ;
4. Precursor materials for chemical weapons;
5. Micro-organism,
6. Counterfeit, altered, or imitation coins, paper money, bank notes, or securities, and forged credit cards;
7. Books, drawings, carvings, and any other article which may harm public safety or morals (obscene or immoral materials, e.g., pornography);
8. Child pornography
9. Articles which infringe upon intellectual property rights.
10. Things to be confused with legitimate products widely known, form counterfeit goods
11. Plants and items which is made from animals (Plant Protection Act)

■ **Regulated Articles** ■

1. Many things of plants and animals are subject to regulation of imports and exports based on the Washington Convention (CITES).
As well as plants and animals that live, it will be subject to regulations for processed goods and products, such as fur, handbags, herbal medicine.
2. Plants and Animals (Fruits, Cut flowers, Dried Flowers, Vegetables, Rice, Meats, Dried meats, Ham, Sausage, etc.) have to be quarantined.
3. Pistols, Air guns, swords, Knives (blade over 15cm) need the permission of the Public Safety Commission.
4. Medicines, cosmetics have restriction of import, even if these are personal effect.

■ **Prohibited items by airlines** ■

The below articles are treated as **Dangerous goods, not accepted by this service. Anything found in your consignment at airport will be removed without any notice to you and would jeopardize whole shipments. However, please note that this rule does regulates only cargo as airfreight, not passenger’s luggage.**

1. Combustibles,
2. Batteries (Batteries should be taken out from any electrical appliance)
3. Gasoline, Fuel oil, Gas, Lighters, Solid fuel.
4. Transceivers and Radio controllers
5. Mobile phone, DS, MP3 player
6. Toner for printers
7. Perfume, Eau de toilette, Aerosol spray, Room fragrance,
8. Nail polish, Nail remover,

❖ **Dangerous Goods for Airfreight Items**

We perform X-ray on each consignment and if any prohibited items are found in your consignment, those will be removed and destroyed.

Besides, it may cause flight disruption and affect another consignments. If you wish to send these items, please take them with you on board as most of them are not prohibited as hand luggage.
