IMPORTANT

Thank you very much for using our YAMATO overseas relocation service.

Customs declaration must be made for customs clearance. Please follow the following steps when you arrive at airport.

STEP 1 Write down **2** Customs declaration sheets before entry into Japan. ※1



※1 Please refer to 『Information about customs declaration』 (Page 4)

※Please get the stamp of immigration from the immigration inspector.

※Please do not pass through the automatic gate.

STEP 2 Hand in the **2** completed sheets to the customs officer and get the stamps.



STEP 3 **1** of the 2 sheets to be returned to you immediately.



STEP 4 Hand over the returned sheet with customs stamp to the Yamato counter at arrival airport. ※2



【!!Attention!!】

Customs officer may tell you to keep the returned customs declaration sheet by yourself, but you must present the form at YAMATO counter at the arrival lobby.

※2 Please refer to 『Information about YAMATO counter』 (Page 3)

If you won't be able to hand over the sheet

- If there is no YAMATO counter at arrival airport..
- If you forget to present sheet to YAMATO counter..
- If YAMATO counter is out of service.

Necessary documents

- ① customs declaration sheet (original ・ be stamped)
- ② copies of passport (the page with photograph and the page with sticker posted by Japan Immigration officer or Re-entry permit stamp to Japan)
- ③ Either a copy of visa or a copy of Resident card.
- ③ is necessary to prove your stay in Japan.

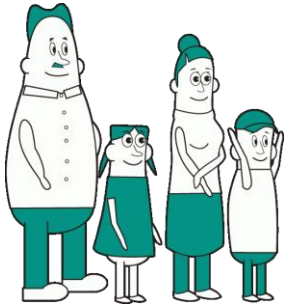

- ① Narcotic drugs, stimulants, marijuana, psychotropic substances, MDMA etc.
- ② Firearms such as pistols, revolvers and machine guns, and bullets or parts thereof.
- ③ Explosives, gunpowder, materials for chemical weapons, germs such as anthrax, etc.
- ④ Counterfeit, altered or imitated coins, bank notes or securities, and forged credit cards.
- ⑤ Obscene or immoral materials, and child pornography.
- ⑥ Articles which infringe upon intellectual property rights. (patent, utility model, design, trademark, copyright, neighboring right, etc.)

② RESTRICTED ARTICLES

- ① Hunting guns, air guns, swords, etc.

- ③ Live animals and plants, meat products (including sausage etc.), vegetables, fruits, rice etc. (Quarantine inspection is required prior to Customs inspection.)

* If you have any unaccompanied articles, please submit this Declaration Form in duplicate. Unaccompanied articles shall be imported within 6 months from the date of your arrival. The sealed declaration must be presented at the time of clearance of the unaccompanied articles.

③ Duty-Free Allowance (excluding crew member)

- * 3 bottles (760ml/bottle) of alcoholic beverages,
- * 400 cigarettes (If you are a Japanese resident, please contact a Customs officer)
- * There is no duty-free allowance for alcoholic beverages and tobacco products for those under 20 years old.
- * 2 ounces of perfume
- * Goods for personal use that were purchased abroad with a total market value not exceeding ¥200,000.
- * When the price of an article exceeds ¥200,000, duties and/or taxes will be imposed on its entire value.
- * As for children under 6 years old, duty-free allowances are limited to the articles owned for their personal use.

Duty free is not be applied to your business goods and product samples.

As regulated by laws and regulations concerned, you are required to declare all the articles that you have purchased or acquired abroad and are bringing into Japan.
Any false declaration or failure to declare may be subject to penalty in laws and regulations concerned.
